COUNT 1: HOMICIDE BY VEHICLE IN THE FIRST DEGREE, O.C.G.A. 40-6-393(a)
in the name of and on behalf of the citizens of the State of Georgia, charge and accuse MARIO DEMAINE CLARK, with the offense of HOMICIDE BY VEHICLE IN THE FIRST DEGREE, for that the said MARIO DEMAINE CLARK, in the County of Chatham and State of Georgia, on or about the 4th day of December, 2020, while driving a motor vehicle, to wit: freightliner flatbed, on I-16 eastbound in Chatham County, did, without malice aforethought, cause the death of Harrison Deal, a human being, through a violation of O.C.G.A. 40-6-390; Reckless Driving, in that he did drive a motor vehicle in reckless disregard for the safety of persons, by following too closely and driving too fast for conditions, contrary to the laws of the State of Georgia, the good order, peace and dignity thereof.

COUNT 2: HOMICIDE BY VEHICLE IN THE SECOND DEGREE, O.C.G.A. 40-6-393(c)
And the jurors aforesaid, in the name of and on behalf of the citizens of the State of Georgia, further charge and accuse MARIO DEMAINE CLARK, with the offense of HOMICIDE BY VEHICLE IN THE SECOND DEGREE, for that the said MARIO DEMAINE CLARK, in the County of Chatham and State of Georgia, on or about the 4th day of December, 2020, while driving a motor vehicle, to wit: freightliner flatbed, on I-16 eastbound in Chatham County, did unlawfully cause the death of Harrison Deal, without an intention to do so, by violating O.C.G.A. Sect. 40-6-1(a), Following too Closely, in that he followed Deal's vehicle more closely than was reasonable and prudent, and said violation caused said death, contrary to the laws of the State of Georgia, the good order, peace and dignity thereof.
