RESOLUTION #2023 -

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF BULLOCH COUNTY, GEORGIA TO MAKE AN APPOINTMENT TO THE BULLOCH COUNTY BOARD OF ELECTIONS AND REGISTRATION; TO REPEAL PRIOR CONFLICTING RESOLUTIONS OR ORDINANCES; TO ESTABLISH AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, local legislation passed by the General Assembly of Georgia established the Bulloch County Board of Elections and Registration ("Board of Elections") on January 1, 2010; and

WHEREAS, said local legislation provides that the Board of Elections shall be composed of three members, each of whom shall be an elector of the county and who shall be appointed by the governing authority; and

WHEREAS, said local legislation further provides that members of the Board of Elections shall be appointed for terms of four years and until their successors are appointed and qualified; and

WHEREAS, said local legislation further provides that each member of the Board of Elections shall be eligible to succeed himself or herself without limitation and shall have the right to resign at any time by giving written notice of his or her resignation to the governing authority of the county and to the clerk of the Superior Court of Bulloch County; and

WHEREAS, said local legislation further provides that any person appointed to fill a vacancy shall serve out the unexpired term of office; and

WHEREAS, Hadley Campbell is a current duly appointed member of the Board of Elections with his term expiring on December 31, 2025, and he has duly submitted his resignation from the Board of Elections to be effective on March 31, 2023; and

WHEREAS, Lawton Sack is an elector of Bulloch County and has consented to serve out Hadley Campbell's unexpired term of office on the Board of Elections;

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of Bulloch County, Georgia ("Board of Commissioners"), and IT IS HEREBY RESOLVED by the authority of same, as follows:

Section 1. Appointment of Lawton Sack to serve out unexpired term of Hadley Campbell. Lawton Sack is hereby appointed to serve out the unexpired term of Hadley Campbell, with his term commencing on April 1, 2023 and ending on December 31, 2025.

<u>Section 2. Repealing Clause.</u> All resolutions, ordinances or parts thereof previously approved and adopted by the Board of Commissioners that are in conflict with the provisions contained in this resolution are, to the extent of such conflict, hereby superseded and repealed.

<u>Section 3. Effective Date.</u> This resolution shall take effect immediately upon its adoption and shall remain in effect until repealed or superseded by further action of the Board of Commissioners.
