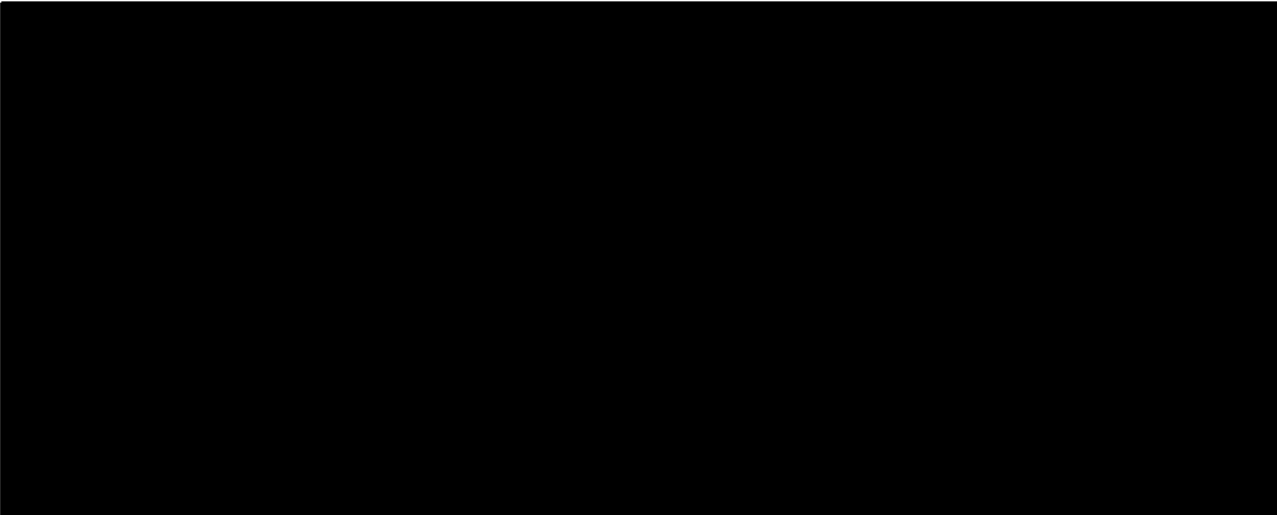

COUNT 1
